### 1. Approval to certify Plainview ISD Board Training

Board Members completed the following certified training credits from January 1, 2014 – January 20, 2015: Brandon Brownlee, 19.75 hours; Sylvia De la Garza, 18.50 hours; Robert Rivera, 16.00 hours; Veronica Salazar-Isaguirre, 15.00 hours; Adam Soto, 18.50 hours; Ron Warren, 18.00 hours; and Bryan Wood, 17.50 hours.

Motion to approve was made by Robert Rivera seconded by Ron Warren, and unanimously carried 6-0.

# 2. Approval under Texas Tax Code Section 34.05 (i) for Sale of Property located in Edmonson, Hale County under Sheriff's Deeds Official Public Recorded at Volume 1059, page 2866.

Mr. Greg Brown Executive Director for Administrative Services, provided information that the land under consideration, consisting of a few lots and a dilapidated house, was "struck off" in 2008. Hale County received an offer to purchase the land, but in order for Hale County to sell the land, all taxing entities must agree to the sale. Proceeds are divided among the taxing entities after the sale. The land will be re-listed on the tax rolls and the new owner will be responsible for taxes assessed beginning with the date of ownership.

Motion to approve was made by Adam Soto, seconded by Robert Rivera, and unanimously carried 6-0.

# 3. Approval of Davis Kinard & Co. PC as the District Auditor for the 2014-2015 Fiscal Year Financial Audit.

The Board approved a recommendation to engage Davis-Kinard & Co. PC as the District Auditor for the 2014-2015 financial audit with fees not to exceed \$34,000 out of the 2014-2015 budget.

Motion to approve was made by Bryan Wood, seconded by Ron Warren, and unanimously carried 6-0.
